



# Canada Post Corporation - Contest

## Who is eligible?

- The contest is open to those in the Canada Post DC component policy #74216.
- Anyone who completes the Retirement goals tool on My Canada Life at Work<sup>™</sup> from Sept. 24, 2021 Oct. 31, 2021 is entered into the contest.
- Those who complete the Retirement goals tool before Sept. 24 will also be eligible.

## When does the contest open and close?

Contest open: Sept. 24, 2021Contest close: Oct. 31, 2021

### How do I enter the contest?

### Online

- Log onto My Canada Life at Work (<u>mycanadalifeatwork.com</u>)
- Click Overview > Set my goal
- Follow the steps to complete Retirement goals tool

## By telephone

 Call the Canada Life Call center at 1-866-716-1313 and ask to speak to a member guide to help walk you through the Retirement goals tool.

### What could I win?

You could win one of five \$100 VISA™ gift cards.

### How the winner will be selected and notified?

- The winners will be randomly selected on Nov. 8, 2021.
- The winners will be contacted by Canada Life at the email address they provide.
- If no response is received after the first contact, another attempt at contact will be made. If phone a
  number is available, Canada Life will follow up with a call within seven calendar days of the initial
  contact.
- If the winner(s) can't be contacted within 14 calendar days of the initial contact, a new winner will be randomly drawn and the previously selected winner will be disqualified.





### 1. How to participate

The sponsor of the Canada Post Contest (Contest) is The Canada Life Assurance Company (Canada Life).

- **1.1 Eligibility:** The Contest is open to members of the Canada Post DC component policy #74216 (Members) who are eligible to participate and meet the following criteria :
  - Employees enrolled in the Canada Post DC component policy #74216
  - Employees must be residents within Canada
  - Employees whose preferred language of correspondence with Canada Life is indicated as English and/or French
  - Set a retirement goal on My Canada Life at Work between Sept. 24, 2021 and Oct. 31, 2021

Members can complete the goal-setting tool by using their current My Canada Life at Work credentials. To be eligible for the Contest, Members need to set a retirement goal by:

- Logging onto My Canada Life at Work (<u>mycanadalifeatwork.com</u>)
- Click Overview > Set my goal
- Complete the goal-setting tool
- **1.2 Contest period:** The Contest period runs from Sept. 24, 2021 12:00 a.m. ET to Oct. 31, 2021 11:59 p.m. ET.
- **1.3 Contest entry:** Members who are in the Canada Post DC component policy #74216of the Canada Post Corporation Pension Plan may enter the contest by logging onto My Canada Life at Work and completing all actions necessary to set a retirement goal. By completing the goal-setting tool (as defined in Section 1.1) automatically enters the Member into the Contest.
- **2. Prize:** There are five prizes of \$100 VISA gift cards (Prize), one prize will be provided to each winner as a gift card.
- **2.2 Prize draw:** On Nov. 8, 202, five winners will be randomly drawn from all Members who have entered. The draw will be held at Canada Life's office at 255 Dufferin Avenue, London, Ontario, N6A 4K1.
- **2.3 Odds:** The odds of being randomly selected to win the Prize depend on the total number of plan members who complete the Retirement goals tool.
- **2.4 Notification of selection:** The selected Members will be contacted by Canada Life at the email address that is associated with the My Canada Life at Work website. If no response is received after the first contact, another contact will be made (if phone number is available, Canada Life will follow up with a call), within seven (7) calendar days of the initial contact. If the selected Member cannot be contacted within fourteen (14) calendar days of the initial contact, another Member will be randomly drawn and the previously selected Member will be disqualified.
- **2.5** To win, the selected Member must respond to the email received from Canada Life, outlined in section 2.4. The selected Member must correctly answer, unaided, a mathematical skill-testing question and will be required to acknowledge the terms outlined in the email. No substitution for or transfer of any of the Prizes will be allowed. If the selected Member does not return via email the answer to the skill-testing question and acknowledgement of the terms seven (7) calendar days after the second email, another Member will be





randomly selected. The previously selected Member will be disqualified and will have no recourse towards Canada Life or anyone involved in the Contest.

#### 3. Further considerations
